PRESCRIBING POLICIES AND GUIDELINES IN THE MANDATORY REGISTRATION OF PERSONS ENGAGED IN BUSINESS AND ADMINISTRATIVE SANCTIONS AND CRIMINAL LIABILITIES FOR NON-REGISTRATION

The following are the covered transactions:

- Sale and/or lease of goods and services through brick-and-mortar stores;
- **E**-commerce or online businesses;
- Operation of digital platforms, including e-marketplace platforms;
- Sale and/or lease of goods and services through digital platforms;
- □ Digital content creation and streaming;
- E-retailing of goods and services;
- Sale of creative or professional services, on-demand or freelance services or digital services supplied over the internet;
- Other forms of businesses other than those mentioned above which are conducted online.

The following are the forms of business operation with their corresponding required place of registration:

Form of Business Operation	Place of Registration
Brick-and-mortar stores	In case of its <i>Head Office</i> , at the BIR district office having jurisdiction over the place of business address. In case of its <i>Branch and/or Facility</i> , at the BIR district office having jurisdiction over the place of business address or location of the branch and/or facility.
